



TURKEY CITIZENSHIP BY INVESTMENT PROGRAM

PROGRAM SUMMARY

Based on Turkish Law on Citizenship, "Acquisition of Turkish Citizenship", with the Law No.5901 promulgated on 28th July 2016, as amended from time to time (the "Act"), and those who obtain a residence permit further to the Law No.6548, by investing within the scope and amount determined by the President, may acquire Turkish citizenship based on the resolution of the President of the Republic of Turkey.

New regulations were published in the Official Gazette on 18th September, the real estate investment decreased from \$1000k to \$250k and the financial estate investment dropped from \$2000k to \$500k. Under the new regulations, foreigners who meet the required investment options will be able to acquire Turkish citizenship for themselves and their families.

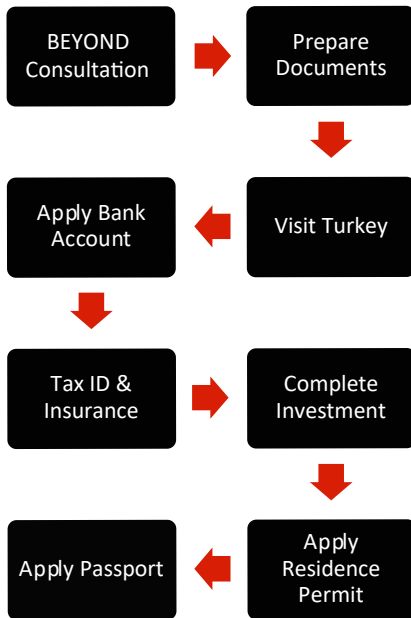

APPLICATION PROCEDURES

The standard application process:



If you need to visit the local property in Turkey, you need to apply for a Turkish visa in advance, and BEYOND can help you arrange your local itinerary.

Or you can choose the BEYOND fast track, and provide POA, you will no longer need to visit Turkey personally.

The process will normally take 6 to 8 months from submission of the application to issuance of the passport.

REQUIREMENTS

The Citizenship by Investment Program requires a person to make a significant economic contribution to the country. The main applicant must be at least 18 years of age to qualify and must meet the application requirements by selecting one of the 2 investment options:
